TERMS & CONDITIONS TO PROVIDE SEMEN FROM

VDL - Contract (NZ)

(NZ Agent: EquiBreed ART)

2024-25 Breeding Season (1 July 24 - 31 March 25)

EquiBreed ART insemination hub in New Zealand is:

- MVS EquiBreed, Waikato region

1. Conditions for contract - "pregnancy fee" basis

i. The semen shall be released on a "pregnancy fee" basis only to

Mares inseminated at an **EquiBreed ART insemination hub**

- **MVS EquiBreed**

and if the following conditions are met:

- a. The semen will only be released on a "pregnancy fee" service fee basis to mares younger than 15 years of age at the time of booking or if the mare is older than 15 years, she has a veterinary certificate confirming that her uterine biopsy score is Type I or Type IIA.
- b. For mares inseminated at an **EquiBreed ART insemination hub**, the service fee will be invoiced immediately upon confirmation of a positive 15-day pregnancy scan or the 28th of February 2025 in the absence of a pregnancy certificate (positive or negative) being supplied to EquiBreed ART.

ii. A **non-refundable booking fee of \$650 + GST is to be paid** by the mare owner to EquiBreed ART to confirm the booking for the above-named mare.

iii. **This booking fee must be paid to EquiBreed ART Ltd prior to the release of any semen** for use in the above-named mare. If the mare is inseminated at the insemination hub, then the booking fee is deductible from the service fee upon confirmation of 42-day pregnancy.

- a. The booking fee for each stallion is payable **per mare**, if a 4th dose is required then the balance of the service fee is payable
- b. The booking fee is not transferable to another mare x stallion combination without written consent from EquiBreed ART
- c. Please refer to Table 1 on page 4.

2. Conditions of contract - Full payment of the service fee is required

- a. Mares inseminated at breeding facilities that are not an EquiBreed ART insemination hub
- b. Prior to shipping semen to a breeding facility that is not an EquiBreed ART insemination hub
- c. Only one pregnancy is allowed per service fee.
- d. Shipping costs are invoiced separately by EquiBreed ART and must be paid prior to shipping semen.

3. The inseminating veterinarian has the authority and discretion to either, not undertake, or cease the breeding program if the mare is deemed unsuitable for any reason. In this case, your veterinarian must provide a report for EquiBreed ART.

General Conditions

4. EquiBreed ART requires that your veterinarian or breeding facility reports the following to EquiBreed ART before 28 February 2025: Mare registered name, owner name, number of straws used for each insemination, AI date, pregnancy details confirmed, stud book registration (NZWA or Hanoverian NZ) and emailed to embryos@equibreedart.com.
5. The mare owner must inform the breeding facility that they are responsible for the security and proper use of the semen in only the mare described in this contract. The mare owner is held accountable for this responsibility.

6. If the above- named mare fails to conceive after 3 cycles, then she shall be withdrawn from the breeding program,
 - a. or EquiBreed ART agree to provide a 4th dose for \$1000+GST, upon receipt of a veterinary certificate detailing doses used, dates of inseminations and any problems, and negative pregnancy certificate(s).
7. **Embryo clause:** VDL frozen semen is eligible to be used in embryo & ICSI programs under the following conditions:
 - a. *In vivo* embryo programs must be undertaken by a registered veterinarian.
 - i. If this is performed by an EquiBreed ART insemination hub, then the booking fee will be payable prior to semen dispatch (up to 3 inseminations allowed for one pregnancy) and the service fee will be payable at 42 days of gestation of the recipient mare.
 - ii. If this is performed by a breeding facility that is not an EquiBreed ART insemination hub, then the full service fee + freight is payable prior to semen dispatch.
 - b. Oocyte recovery (OPU) and ICSI is only performed by EquiBreed ART Ltd
 - i. A booking fee (\$1000 +GST) is payable upon commencement of the ICSI project per mare x stallion combination and will be allocated to the first embryo attempt for that OPU session.
 - ii. If more than one embryo is produced in an oestrous cycle or OPU session (by embryo flushing or ICSI) then full service fee will be payable for each subsequent day 42 pregnancy achieved.
 - c. EquiBreed ART reserves the right to thaw all embryos frozen at EquiBreed ART for transfer or shipping.
 - d. If an embryo is thawed at EquiBreed ART and shipped to another veterinary practice for transfer, then the full service fee and associated embryo thaw, dispatch and shipping costs will be payable before dispatch of the embryo.
8. **Semen request process**
 - a. Acceptance of this contract.
 - b. Upon completion of the contract, we will contact you to organize the dispatch of the semen to your preferred breeding facility and confirm freight charges.
 - c. Upon payment of your account the semen will be authorized by EquiBreed ART for shipping to your selected veterinary clinic within 3-5 working days or as soon as a dry shipper is available.
 - d. We will only ship semen Monday-Thursday
 - e. The dry shipper must be returned to EquiBreed ART within 7 days of semen shipping to avoid penalties. Transfer the semen immediately into a storage tank, do not store semen in the dry shipper.
 - f. If the semen is damaged in transit or during storage at the breeding facility then the full service fee will be payable to replace the damaged semen.
 - g. To avoid problems, please ensure your preferred breeding facility has adequate semen storage facilities and frozen contents insurance.
9. If the semen requested is no longer available, then the client can select semen from a stallion of similar value from the same stud.
10. This contract is separate to any contract between the mare owner and the veterinary practice or breeding facility managing the mare's breeding program (including MVS EquiBreed).
11. I agree that if the above-named mare fails to conceive that I will not hold EquiBreed ART or the stallion stud responsible, and I agree to pay all fees incurred for services provided by EquiBreed ART.
12. This contract is non-transferable without the written authorization from EquiBreed ART.
13. Neither the stallion stud nor EquiBreed ART makes any representation regarding the mare or stallion's fertility.
14. All invoices will be payable within 7 days of invoice or prior to semen dispatch.
15. A veterinary certificate must be provided to EquiBreed ART certifying the inseminated mare is not in foal within 14 days of the pregnancy examination if this examination was not performed at an Insemination Hub.
16. All pregnant mares will require a veterinary examination at 15, 30 and 45 days of gestation. If these examinations are not performed or a veterinary certificate not provided, then rights to a "free return" will be waived.
17. **FREE RETURN:** In the event of the mare losing the pregnancy after 45 days of gestation or the foal dying within 24h of birth, a free return will be offered from the same stallion or one of equivalent value.
 - a. The free return is only made available to mares less than 15yo or with a uterine biopsy score of Grade I or IIA, at the time of the repeat / replacement breeding.
 - b. **The free return is only made available to mares that are managed and inseminated by a registered veterinarian.**

- c. This free return will only be made available upon receipt of a veterinary certificate which states that the mare has aborted, or the foal died within 24h of birth. This veterinary certificate needs to be sent to EquiBreed ART within 14 days of the time of diagnosis of the pregnancy loss or the death of the foal.
 - d. This free return will not be made available to mares that die, abort twins, have been seriously injured, are considered sub fertile, have a uterine biopsy score poorer than Grade IIA, or considered to be in poor health or condition as described in a veterinary certificate.
 - e. This free return will not be made available to mares that have foals with abnormalities, congenital or otherwise.
 - f. If the free return clause is used and involves a swap to a stallion of higher value than the original stallion, then the difference in the pregnancy fee will need to be paid up front.
 - g. The free return will provide up to 2 doses of semen for the one mare, or a pregnancy is achieved, whichever happens first.
 - h. The free return is only valid for 12months after the date of this contract.
18. Release of semen to another breeding facility (not an EquiBreed ART insemination hub) for insemination requires this contract to be accepted by completion of the contract and will incur the full payment of the service fee + freight prior to its release.
- a. Only 1 dose of semen shall be released at any one time and only 1 pregnancy is allowed per dose of semen dispatched or per contract.
 - b. The mare owner will be responsible for any semen dispatch, storage and freight charges incurred by EquiBreed ART or your chosen breeding facility.
 - c. The insemination hubs may store a selection of stallions available for your breeding program, it is possible that not all stallions listed are immediately available at an insemination hub.
 - d. **Any unused semen must be returned to EquiBreed ART within 6 weeks of dispatch from EquiBreed ART at the cost of the mare owner.**
 - e. If any semen is used contrary to the conditions of the contract or if more than one foal is produced per insemination or ICSI dose of semen, then the mare owner will be liable for the value of the additional service fees incurred.
19. **Only one pregnancy is allowed per mare contract.**
20. The mare owner and their chosen breeding facility are responsible for reporting to EquiBreed ART all confirmed pregnancies obtained using this semen.
21. **EquiBreed ART terms and conditions apply to this contract. These are available from our office or on the website <http://www.equibreedart.com>**
22. Any changes to this agreement must be agreed upon by both parties in writing or by email to embryos@equibreedart.com. This contract supersedes any previous verbal or other discussions that involve use of frozen semen for this breeding program.
23. In the event of any dispute between the parties in relation to these Terms of Trade (but excluding a dispute relating to payment of monies due) the parties will first seek to resolve such dispute by promptly giving notice to the other party and will co-operatively endeavor to resolve the dispute. If the dispute remains unresolved the parties will first seek a resolution using mediation or other informal method of resolution before pursuing arbitration or resolution through the Courts.
24. Payment for the semen and / or insemination of your mare confirms acceptance of the terms and conditions of this contract.
